The unders.ign.ed as incorporator(s) of the corporation pursuant to Chapter 617,2020, Florida Statutes, adopt the following Articles of Incorporation for such corporations.

#### Article 1. Name

# Article 2. Period of Existence

The period of duration of this non-profit corporation is perpetual unless dissolved according to law,

# Article 3. Purpose

This non-profit corporation shall not endorse a candidate for public office. Neither the name of this corporation nor the name of any officers or directors in official capacity shall be used by any officers or directors in official capacity shall be used in any connection with a commercial concern or with any political interest, provided, however, that this corporation may endorse or oppose pending legislation and assume a stand on matters of public policy if so recommended by its members.

# Article 5, Membership

The membership of this corporation shall consist of two classes, regular and associate. The corporation shall be the sole judge of the qualification and classification of its members. Provisions for qualifying., classifying, admitting, and terminating of members shall be made in the by laws.
