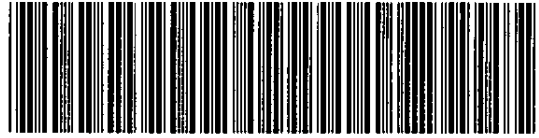

ARTICLE I

The name of the Corporation is Institute for Self Active Education, Inc.

ARTICLE II

The principal place of business is 2255 Meadowlane Avenue, West Melbourne, Florida 32904, and the mailing address is P.O. Box 511001, Melbourne Beach, Florida 32951.

ARTICLE III

The specific purpose for which the corporation is organized is to provide professional development services designed to stimulate creativity. The corporation is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the internal Revenue Code, or corresponding section of any future federal tax code.
