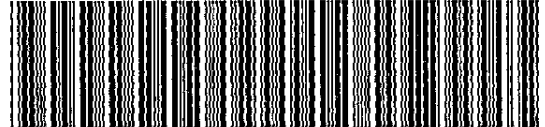

**Articles of Incorporation
(Amended)
OF
The Crumley Family Education Fund, Inc.**

Pursuant to Chapter 617. 0202, F.S., the articles of incorporation set forth the following:

- Article I: The name of the Corporation is The Crumley Family Education Fund, Inc.
- Article II: The principal place of business and the mailing address of the registered office is 6216 Whittondale Drive, Tallahassee, Florida 32312, in Leon County.
- Article III: The Corporation is organized for the purpose of building the institution of family, to keep each individual family member healthy (physically, emotionally and spiritually) for the betterment of the whole family unit, through education and providing support of such services.
- Further, said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, that qualify as exempt under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The term of the corporation shall be perpetual.
- Article IV: The initial Directors are by appointment of the initial officers of the Corporation, and any subsequent Directors shall be elected by secret ballot as described in the by-laws of the Corporation.

- Article VI: The names and addresses of the persons who are the initial trustees of the corporation are as follows:
- Blanche M. Harris – 65 Sanford Heights, Thomasville, Georgia 31757.
David Harris, Jr. – 6216 Whittondale Drive, Tallahassee, Florida 32312.
- Article VII: No part of the net earnings of the corporation shall inure the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation

shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IX: The initial registered agent of the Corporation is Margie A. Harris. The street address of the registered agent is 6216 Whittondale Drive, Tallahassee, Florida 32312.

Article X: The incorporator of the Corporation is David Harris, Jr. The street address of the incorporator is 6216 Whittondale Drive, Tallahassee, Florida 32312.
