ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Cornerstone International Baptist Church, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 12502 Ivy Bellflower Drive, Jacksonville, Florida 32225.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: To operate as a church, and to operate exclusively for charitable and educational purposes, including but not limited to improvement of the condition of the poor, the underprivileged, and the victims of discrimination and alienation.

To accomplish these purposes, the Board shall have the authority to exercise all the powers conferred upon corporations formed under the laws of the State of Florida in order to accomplish its charitable and educational purposes, including but not limited to the power to accept donations of money or property, whether real or personal, or any interest therein, wherever situated; provided that only such powers be exercised as are permitted to be exercised by a nonprofit corporation which qualifies as a corporation in Section 501 (c) (3) of the Internal Revenue Code as amended; nor shall it engage directly or indirectly in any activity which would cause the loss of such qualification.

ARTICLE IV MANNER OF ELECTION

Section 1. <u>General powers</u>. The Board of Directors of Cornerstone International Baptist Church, Inc. shall constitute its governing body. It shall manage, control, and direct the affairs and property of the corporation and subject to these bylaws shall have all powers necessary to carry out the purposes of the church as specified in the laws of the United States and the State of Florida.

Section 2. <u>Composition of the Board</u>. The members of the initial Board shall be those two persons named as directors in the Articles of Incorporation, plus such persons as shall be added to the Board before December 31, 2005. Thereafter, the Board shall consist of not less than five, nor more than seven members. The term of the initial directors shall be two years. Thereafter, all directors shall be elected every two years by a majority vote (two-thirds) of the active members of the church.
