

ARTICLES OF INCORPORATION

TALLAHASSEE, FLORINA

OF

All Nations Global Discipleship Ministries,

A FLORIDA NON-PROFIT CORPORATION

The undersigned incorporator, in order to form a nonprofit corporation under the laws of the state of Florida, adopt the following Articles of Incorporation:

ONE: The name of this corporation is All Nations Global Discipleship Ministries, Inc. The principal address of the corporation is 4020 58th Ave. N, St. Petersburg, Fl 33714.

TWO: The principal office address of this corporation is:

4020 58th Ave. N

St. Petersburg, Fl 33714

THREE: The specific purposes for which this corporation is organized are to operate exclusively for religious, charitable, and educational purposes. This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. In addition, the corporation is organized for the following purposes:

A) To establish an international Church which will preach, teach and make disciples of all men, and teach them how to live a victorious life according to God's Word.

- B) To teach and lead people to a place where they operate proficiently in the biblical principles of faith, love, healing, prosperity, redemption, the kingdom & righteousness. In addition, they will be able to share these biblical principals with others.
- C) To reach the lost and assist believers in becoming rooted, grounded and established in the Word of God. This will be accomplished by teaching them of the Kingdom of God, which is already within them. (Luke 17:20-21)
- D) To expound on the things of the Kingdom of Heaven, that have been suffering violently. (Matthew 11:12)
- E) To build an army of disciples, bringing them from carnal man to spiritual men of God. In doing so, we are called to train men and women to become skillful in the work do righteousness, to stand firm in the spiritual warfare against the kingdom of darkness. (Hebrews 5:12-14, Ephesians 6:10-18)
- F) To evangelize all nations proclaiming that "Jesus is Lord" from the top of the world to the bottom and all the way around. The vision is to be accomplished through the efforts of Rev. Anthony Oliver and his wife Judy, and church staff. The church will hold youth rallies, open air crusades, net working through schools, reaching prisoners, hospitals, radio, tapes, feeding clothing and by personal evangelism. In addition, the Church has opened a ministry center in Trinidad.

FOUR: PROHIBITED TRANSACTIONS

This corporation shall not:

- a) Engage in any activities prohibited by Section 617.0105, Florida Statutes;
- b) As a substantial part of its activities carry out propaganda or otherwise attempt to influence legislation;

- c) Participate or intervene, by publication or distribution of any statements or otherwise, in any political campaign on behalf of any candidate for public office;
- d) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- e) Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by the organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

FIVE: The Directors of the Corporation shall be elected in accordance with the provisions stated in the bylaws.

SIX: The number of initial directors of this corporations are three. Their names and address are as follows:

EIGHT: The initial registered agent and street address are as follows:

NINE: The classes, rights, privileges, qualifications, and obligations of members of this corporation are as follows:

The corporation shall not have a membership distinct from the Board of Directors. In accordance with the Bylaws, the Board of Directors will be the only legal membership of this organization.

TEN: Any additional provisions for the operation of the corporation are as follows:

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

In any taxable year in which this corporation is a private foundation as described in Section 509(a) of the Internal Revenue Code, the corporation 1) shall distribute its income for said period at such time and manner as not to subject it to tax under Section 4942 of the Internal Revenue Code; 2) shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code; 3) shall not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code; 4) shall not make any investments in such manner as to subject the corporation to tax under Section 4944 of the Internal Revenue Code; and 5) shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code.
