Articles of Incorporation of FROG Worldwide, Inc.

This corporation is organized exclusively for one or more of the purposes as specified 501(c)(3) of the Internal Revenue Code, including, for such purposes, the modistributions to organizations that qualify as exempt organizations under section 50 the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The purpose for which this corporation is organized is to assist people throughout the U States and the world with educational supplies and instruction.
