ARTICLES OF AMENDMENT NUMBER TW0

The following provisions of the Articles of Incorporation of NORTHWOOD VILLAGE ASSOCIATION, INC., a Florida corporation, filed in Tallahassee, Florida, on February 10, 2005, are hereby amended as follows:

1. Article IX shall be amended to read in its entirety as follows:

IX. CORPORATE EXISTENCE

The Association shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. In the event the Association is dissolved, the control of and right of access to the property containing the surface water management system facilities (the "Facilities") shall be conveyed or dedicated to a governmental unit or public utility that will accept responsibility for the maintenance and operation of the Facilities. If upon dissolution the Facilities are not accepted by a governmental unit or public utility, then the Facilities shall be conveyed to a similar non-profit corporation that has the power and authority to operate and maintain the Facilities.

- 2. In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
- 3. The amendment was adopted by the members on hornbu 6, 2006. The number of votes cast for the amendment was sufficient for approval.
