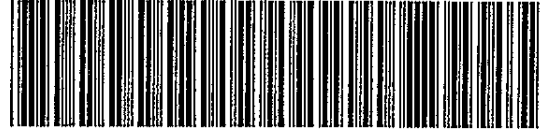

**ARTICLES OF INCORPORATION
OF
SPLINTER YOUTH, INCORPORATED
A Not For Profit Corporation**

**ARTICLE I
NAME**

The name of the corporation shall be SPLINTER YOUTH, INCORPORATED.

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

The street address of the initial principal office is: 7809 North Orleans Avenue, Tampa, Florida 33604. The mailing address of the corporation shall be 7809 North Orleans Avenue, Tampa, Florida 33604.

**ARTICLE III
PURPOSE**

The purpose for which the corporation is organized is to develop a stable community where youths can learn, grow, express themselves and feel accepted in a safe, engaging and relevant atmosphere, so they will enter adulthood with character and integrity.

**ARTICLE IV
MANNER OF ELECTION OF DIRECTORS**

The Board of Directors of the corporation shall consist of at least three persons, who shall be selected by the Member in the manner set forth in the by-laws.

**ARTICLE V
INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of the corporation and the name of the initial registered agent at that address are: 7809 North Orleans Avenue, Tampa, Florida 33604; Registered Agent: Mark Jannetta.

ARTICLE VI INCORPORATOR

The name and address of the incorporator is: Mark Jannetta, 7809 North Orleans Avenue, Tampa, Florida 33604.

ARTICLE VII AMENDMENT

This corporation may amend its certificate of incorporation in any respect, provided that only such provisions shall be inserted by amendment as would be lawful and proper in an original certificate of incorporation made at the time of making such amendment. Every amendment shall be proposed by a Member and approved by a majority of the Members.

ARTICLE VIII NO DISCRIMINATION

The corporation will be an equal opportunity organization, and there shall be no discrimination in membership or in hiring of employees based on race or national origin.

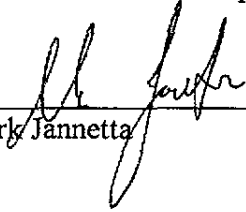
ARTICLE IX EXCLUSIVE CHARITABLE PURPOSES

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under Section 501(c)(3) of the Internal Revenue Code.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to, its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on or propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

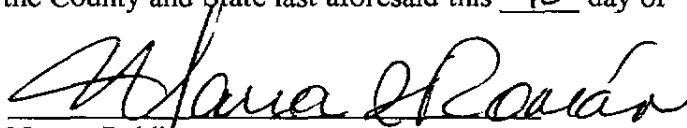

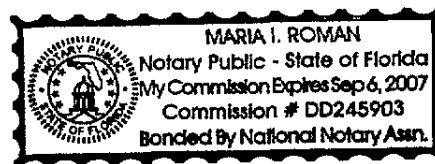
