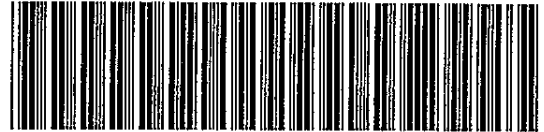

**ARTICLES OF INCORPORATION FOR
BLASER FAMILY FOUNDATION, INC.**

The undersigned incorporator, in compliance with Chapter 617 of the Florida Statutes (Corporations Not for Profit), for the purpose of forming a Florida Not for Profit corporation, under the laws of the State of Florida does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of the Corporation shall be Blaser Family Foundation, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal place of business and the mailing address will be 10104 SW 17th Place, Gainesville, Florida 32607.

ARTICLE III - PURPOSE

The purpose for which the Corporation is organized is to benefit public and religious charitable organizations. The Corporation shall have all of the powers vested in a Corporation organized and existing by virtue of such laws.
