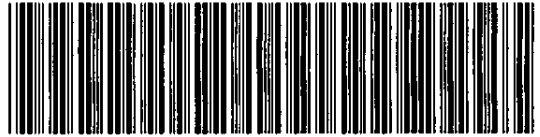

of distribution to organizations under section 501 (C)(3) of the Internal Revenue
code (or the corresponding section of any future Federal tax code). No part of the net
earning of Tabernacle Missionary Baptist Church of West Hollywood Florida
shall inure to the benefit of, or be distributed to its members, trustees, directors, officers
or other private persons except that the corporation/organization shall be
authorized and empowered to pay reasonable compensation for services
rendered and to make payments and distributions in furtherance of
section 501 (C)(3) purposes. No substantial part of the activities of
the corporation/organization shall not participate in or intervene in
(including the publishing or distribution of statements) any political campaign.

Article X. – Limitations

on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation/organization shall not carry on any other activities not permitted to be carried on (a) by a corporation/organization exempt from Federal income tax under section 501 (C)(3) of the Internal Revenue Code or (corresponding section of any future Federal tax code) or (b) by a corporation/organization, contributions to which are deductible under section 170 (C)(2) of the Internal Revenue Code or (corresponding section of any future Federal tax code).

Upon the dissolution of the Tabernacle Missionary Baptist Church of West Hollywood, assets shall be distributed for one or more exempt purposes within the meaning of section 501 ©(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes. In addition, upon dissolution of the Organization all assets will be donated to an upcoming new church. At the time of dissolution the church of choice will be determined.
