

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment(s) to its Articles of Incorporation:

**Article II. Purpose and Powers, Section 1. Purpose** shall be amended and read as follows:

The purpose for which the Corporation is organized is to provide an entity for the operation and governance of Miranda Manor, A Condominium (the "Condominium"), located upon lands in Hillsborough County, Florida, said property being described in the duly recorded Declaration of Condominium applicable thereto.

The Corporation shall not be operated for profit and shall make no distribution of income to its members, directors or officers.

**Article III. Developer** shall be amended and read as follows:

107 S. Fielding, LLC, a Florida limited liability company, shall make and declare or has made and declared a certain Declaration of Condominium submitting to condominium ownership certain property described therein under the terms, covenants, and conditions expressed more fully therein; the Condominium is to be known as **MIRANDA MANOR, A CONDOMINIUM.**
