The undersigned, for the purpose of forming a not-for-profit Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**Article I  
Name**

The name of the Corporation shall be New Direction International Women's Outreach Ministries, Inc., (hereinafter called the "Corporation").

**Article II  
Principal Office and Mailing Address**

The principal office and mailing address of the Corporation is, 1601 W. 36<sup>th</sup> Street, Riviera Beach, Florida, 33404.

**Article III  
Purpose**

The specific purpose of this not-for-profit Corporation is for the charitable, religious and educational training purposes in Section 501 (c) 3 of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit Corporation may be organized, so far as is or may be permitted by laws of the State of Florida and Section 501 (c) 3 of the Internal Revenue Code 1986 as amended New Direction International Women's Outreach Ministries, Inc. Also, there will be several programs organized to operate through New Direction International Women's Outreach Ministries, Inc., BSOP – Bible Study Outreach Program; YWOM – Young Women Outreach Ministry; EME – Evangelists Mentoring Evangelists; MCWT – Mother Can We Talk Ministry; WOM – Widows Outreach Ministry; CHARP – Christian Help And Resource Program; SROP – Senior Resource Outreach Program; AVTP – A Voice To Pray Chat Room; SWRP – Single Women Resource Program; FACP – Family and Children Program; CCP – Christian Counseling Program; Reaching Behind The Wall Prison Outreach Ministry; Retreats, Conferences, Seminars, Revivals and Personalized Workshops, etc.

**Article IV  
Membership**

Any person, relative, corporation, partnership, association or organization who is interested in the purpose of the Corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the Corporation, and who complies with the requirements established from time to time by the by-laws, shall be eligible for membership.

**Article V  
Initial Registered Office Agent**

The street address of the initial registered office of the Corporation is 1601 W. 36<sup>th</sup> Street, Riviera Beach, Florida 33404. The initial registered Agent shall be Willie Mae Lee.

**Article VI  
Board of Directors**

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than five (5) Directors. The number of Directors may be increased or decreased from time to time, in accordance with the by-laws of the Corporation, but shall never be less than five (5). The manner of election of Directors shall be regulated by the by-laws.

**Article VII  
Incorporator**

The name and address of the person signing these Articles of Incorporation is Willie Mae Lee, 1601 W. 36<sup>th</sup> Street, Riviera Beach, Florida, 33404.

**Article VIII  
Dissolution**

Upon the dissolution or winding up of this Corporation, it's assets remaining after payment or provisions for payment of all debts and liabilities of the Corporation shall be distributed to a not-for-profit fund, foundation or corporation, which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) 3 of the Internal Revenue Code 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

**Article IX  
Limitations**

No part of the net earning of the Corporation shall inure to the benefit of, or be distributed to it's Directors, Officers, Members or other private person, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of any of it's purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations (except as otherwise provided in subsection (h) of Section 501 (c) 3 of the Internal Revenue Code 1986, as amended), and the Corporation shall not participate or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Code 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a Corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).
