ARTICLES OF INCORPORATION SONS OF THE FATHER MINISTRIES, INC.

ARTICLE I - NAME

The name of the corporation shall be Sons of the Father Ministries, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is:

ARTICLE III - PURPOSE

The purpose for which the corporation is organized is:

- 1. To bring people to a personal relationship with Jesus Christ as Lord and Savior through the proclamation of the gospel.
- 2. To conduct services, workshops, retreats, and other activities for the propagation of the Gospel.
- 3. To glorify Jesus Christ through ministry to the broken-hearted, to the hurting and sick, and to those held in spiritual captivity and to minister to the spiritual, financial mnd physical needs of the community as the needs may arise.
- 4. To solicit funds, collect monies, receive gifts and bequests, and to otherwise raise money to fulfill the stated purposes of the corporation.
- 5. To purchase, lease, rent, acquire, own, hold in trust, use, sell, convey, mortgage, or otherwise dispose of any real estate or chattels as be necessary to hold in trust properties for the stated purposes of the corporation.
- 6. To borrow money, issue bonds, debentures, notes, or other obligation, secure for monies so borrowed or in payment for property for the purposes of the corporation.

7. To govern itself according to these articles of incorporation and by-laws adopted by establishing and maintaining such departments, institutions, and services as well as employing such staff as required for the propagation of the Gospel.

ARTICLE IV - OFFICERS, BOARD OF DIRECTORS AND MANNER OF ELECTION

- The corporation shall be governed by a Board of Directors consisting of the officers and a 1. minimum of two (2) directors at large and a maximum of six (6) directors at large. The officers shall be the President, Vice President, Secretary/Treasurer.
- 2. The officers shall be elected every four years by the Board of Directors and shall serve until such time as their successors are duly elected and take office.
- 3. Upon initial establishment of the corporation the officers and Board members shall be appointed by the President. Thereafter, Board members shall be nominated by the President and confirmed by the majority vote of the Board at any meeting of the Board.
- The Board shall meet no less than twice annually and may meet in person, telephonically, 4. or by other electronic means.
