

**EXHIBIT "A"**

**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION  
OF ARBOR RIDGE HOMEOWNERS ASSOCIATION OF APOPKA, INC.**

1. Article V of the Articles of Incorporation of Arbor Ridge Homeowners Association of Apopka, Inc. (the "Articles") is hereby modified to add the following language:

The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District permit no. 40-095-91005-1 and 40-095-91005-2 requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water management system.

The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

2. Article X of the Articles of Incorporation of Arbor Ridge Homeowners Association of Apopka, Inc. are hereby modified to delete the last sentence in its entirety and replace with the following:

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

Unless otherwise provided herein to the contrary, all terms and words utilized herein shall be as defined in that certain Declaration of Conditions, Covenants, Easements and Restrictions for Arbor Ridge recorded February 17, 2005, as amended by that certain First Amendment to Declaration of Conditions, Covenants, Easements and Restrictions for Arbor Ridge dated April 11, 2005 and recorded April 29, 2005 and Second Amendment to Declaration of Conditions, Covenants, Easements and Restrictions for Arbor Ridge to be recorded in the Public Records of Orange County, Florida (collectively, the "Declaration").
