**ARTICLES OF INCORPORATION
OF
Fishhawk Youth Sports Association Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: **Fishhawk Youth Sports Association Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
15028 Eaglerise Drive , Lithia, Florida 33547

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: The corporation is organized for the sole purpose of establishing and providing sports for the youth of Lithia and surrounding areas in Hillsborough County, Florida. We will utilize the county park currently under construction starting in 2005 to provide baseball, football, and soccer leagues for youth from the ages of 4 - 19. The corporation will use all proceeds to further the development of the youth sports for the children who participate in the leagues and events organized by the corporation. The leagues that will be managed by the corporation include the following: Babe Ruth/Cal Ripken Baseball and Softball - The corporation anticipates participation of 500 - 1000 children in the baseball league organized by the corporation. This league will be a licensed affiliate of Babe Ruth/Cal Ripken Baseball and Softball. This league will be for children aged 5 - 19. Fishhawk Youth Football and Cheerleading - The corporation expects up to 300 children to participate on our football and cheerleading teams. These teams will be affiliated with a local conference to be determined after application. These teams will be for children between the ages of 5 - 16. Fishhawk Youth Soccer - The corporation expects to establish recreational and competitive soccer leagues and teams that will be affiliated with the Florida Youth Soccer Association. We expect 200 - 300 children to participate in this program. Children between the ages of 4 - 19 will participate in this program.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE IV INITIAL REGISTERED AGENT & STREET ADDRESS

The name and address of the initial registered agent is: Business Filings Incorporated, 660 East Jefferson Street, Tallahassee, Florida, 32301. Located in the County of Leon

ARTICLE V INCORPORATOR

ARTICLE VI DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

ARTICLE VII MANNER OF ELECTING DIRECTORS

The method of election of directors is as stated in the bylaws.


