The undersigned, a majority of whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Nonprofit Corporation Law of Florida, do hereby certify:

## ARTICLE I CORPORATION NAME

The name of said corporation shall be: Think So Unique, Inc.

## ARTICLE II PLACE OF CORPORATION

The place in Florida where the principal office of the corporation is to be located at is: 5756 Randall Rd., Frostproof, Fl 33843 The mailing address is: P.O. Box 1026 Frostproof, Fl 33843

#### ARTICLE III CORPORATE PURPOSES

The purposes for which said corporation is formed are:

- (A) To receive and maintain real or personal property, or both and subject to the restrictions and limitation hereafter set forth, to use and apply the whole or any part of the income and the principal thereof exclusively for educational, religious, and charitable purposes either directly or by contributions to organizations that qualify as exempt organizations under Section 501 (C) (3) of the IRS code and its regulations as they now exist or they may hereafter be amended. This organization will embrace the public through innovative approaches and comprehensive services that will aid the underprivileged and disadvantage individuals and families which will lead to a conducive life of self-sufficiency. More specifically, these purposes and services are for the youth and adults and shall include but are not limited to:
- · Life Skills, Job Training, Job Placement, Employment
- · Land Acquisition, Residential Housing, Child Care
- · Counseling, Tutoring, Literacy, Character Enhancement
- Juvenile Delinquency, Substance/Physical Abuse,
- · Teen Pregnancy, Abstinence, AIDS, Parenting

(B) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

(C) Upon the dissolution of the Corporation, the Board of Directors shall, after paying or adequately providing for all the debts, obligations, and liabilities of the Corporation, distribute the remaining assets of the Corporation exclusively for the nonprofit religious purposes to such organization or organizations of like interest which are tax exempt under section 501 (C) (3) of the Code, as amended, as the Board of Directors in its sole discretion shall determine. The extent of personal liability, if any, for directors, officers, or members for corporate obligations and the methods of enforcement and collection, are as follows: NONE. Further, the Directors and Officers shall be exempt from liability and / or indemnified from costs and judgments to the full extent permitted by Florida law. In the event the (Florida) law is subsequently amended to authorize the further elimination or limitation of the liability of Directors or Officers of nonprofit corporations, then the liability of Directors and officers of the corporation in addition to the limitation on personal liability provided under this Article, shall be limited to the fullest extent permitted by such later amended Florida law.
