## ARTICLES OF INCORPORATION In Compliance with 617, F. S., (Not for Profit)

<u>JobsHouse</u>, <u>Inc.</u>
(A not-for-profit corporation)

We, the undersigned, with other persons being desirous of forming a corporation authorized to exercise powers permitted non-profit corporations for educational, charitable and philanthropic purposes, under the provisions of Chapter 617 and Chapter 496 of the Florida Statutes: provided however, that this corporation in exercising any one or none of such powers shall do so in furtherance of the exempt purpose for which it has been organized and described in Section 501 (c) (3) of the Internal Revenue Code; do agree to the following:

#### ARTICLE I NAME

- 1. The name of this corporation is JobsHouse, Inc.
- 2. The corporation is to exist perpetually.

#### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of the JobsHouse Corporation shall be at 2905 Pierce Street, Suite # 10, Hollywood, Florida 33020 during the period of incorporation and until the first meeting of the Board of Directors at which time a location will be designated in accordance with Article X of the By-Laws.

#### ARTICLE III PURPOSE

- 1. The purpose for which the corporation is organized is to provide jobs and housing and assistance, support to further promote the continuing recovery efforts of individuals and families participating in the JobsHouse, Inc. program for: (a) personnel serving in or associated with addictions facilities or programs (b) personnel interested in addictions studies (c) scholarships and aid for individuals to attend or participate in treatment, prevention, rehabilitation and other allied services for substance abuse.
- 2. To increase public understanding of the problems of addictions.
- To establish and maintain an Information Center for the collection and dissemination of information regarding the promotion, recognition, evaluation, counseling and scholarships for the JobsHouse, inc. Program.

- 4. To stimulate and encourage participation in all aspects of the JobsHouse, Inc. programs.
- 5. To buy, sell, acquire, operate, construct, lease and maintain houses, offices, libraries, equipment and other real, business and personal property for the use and benefit of the corporation.
- 6. To operate in furtherance of Chapter 396, Chapter 397, and Chapter 496 of the Florida Statutes.
- 7. All policies and activities of the corporation shall be in concert with applicable U.S. laws.

#### ARTICLE IV MANNER OF ELECTION

- 1. The manner in which the directors are elected or appointed: Members of the Board of Directors shall be elected and hold office in accordance with the by-Laws.
- The Board of Directors shall be members of the Corporation.
- 3. Board of Directors may be changed from time to time by the By-Laws, but shall never have less than (3) members.
- 4. Each director shall have one vote and such voting may not be done by proxy.
- 5. Vacancies in the board of directors shall be filled by a vote of the majority of the remaining members of the Board of Directors
