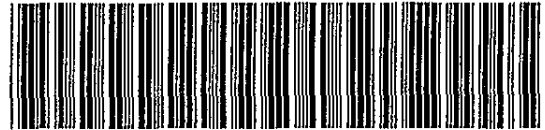

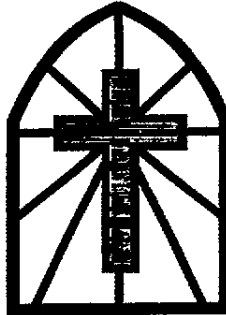

**PREAMBLE**

Whereas, we, a body of believers in Jesus Christ, collectively joined together for the sole purpose of the gospel of our Lord as recorded in the Holy Scripture, deem it wise that we have certain laws to serve as a criterion to work by; therefore it is resolved: that beginning with its legal adoption thereof we shall be governed by the following Articles of Incorporation.

**ARTICLE I-NAME**

The name of this organization, a non-profit religious corporation organized under the laws of the state of Florida, is Mt. Sinai Holy Temple #2, Inc.

**ARTICLE II-PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 2526 Sandy Lane, Orlando, FL 32818

**ARTICLE III-PURPOSE**

1. To minister to people of all faith.
2. To provide several outreach ministries for those in need.

#### ARTICLE IV-MANNER OF ELECTION

1. **President/Pastors:** Ultimate authority in the church shall reside with the President/Pastor under the teaching of Jesus Christ, the Head of the Church.
2. **Vice President/Deacons:** Appointed by the President/Pastor, must be an active member of the church in good standing, willing to serve and follows the rules of the church according to the Word of God, to make sure all rules and regulations of the church are carried out, to maintain order of the church in the absence of the President/Pastor.
3. **Secretary:** Appointed by the President/Pastor, must be an active member of the church in good standing, willing to serve and follows the rules of the church according to the Word of God, to maintain records of all funds, to keep the minutes for all meetings and do all record keeping for the church.
4. **Treasurer:** Appointed by the President/Pastor, must be an active member of the church in good standing, willing to serve and follows the rules of the church according to the Word of God, must be willing to collect tithes and offerings. Person collecting tithes and offerings shall keep a record of all monies received and deposit all funds into church accounts in financial institutions used by the church. The treasurer shall provide monthly and annually receipts for members who make offerings to the church before the end of the fiscal year.
