**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF LARRY SHARLEY COLLEGE OF LAY EVANGELISM, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned Florida corporation not for profit hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Larry Sharley College of Lay Evangelism, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - ADOPTION AND TEXT OF AMENDMENTS

The sole member of the Corporation approved the resolution amending Article I of the Articles of Incorporation on February 24, 2005, and the number of votes cast for the amendment was sufficient for approval.
