The name of the corporation shall be:

Addendum to Article III - Purpose

New Alpha Worship Center narrative related to section 501 c (3) of the IRS Code.

The New Alpha Worship Center is organized and shall be operated exclusively for the charitable purposes within the meaning of section 501 c (3) of the Internal Revenue Code to reach souls for the Kingdom of God by preaching and teaching the unadulterated Word of Truth.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by the corporation exempt from Federal income tax under section 501 c (3) of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170 c (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

Upon winding up and dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and or scientific purposes and which has established its tax exempt status under section 501 c (3) of the Internal Revenue Code.
