III. PURPOSES

The corporation is organized and operated to further the common good and general welfare of the property owners in the Gately Ridge development. The corporation has not been formed for pecuniary profit or financial gain, and no part of the net earnings of the corporation shall be distributable to or inure to the benefit of its officers or directors or any private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of its purposes as set forth in this Article III. The Association shall operate, maintain, and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns Water Management District permit no. 42-031097943-1 requirements and the applicable District rules and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system. The Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

XII. DISPOSITION OF ASSETS UPON DISSOLUTION

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation oand maintenance of the surface water or stamwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approv3ed by the St. Johns River Water Management District prior to such termination, dissolution or liquidation. Further, the Directors shall, after paying or making provision for the payment of all liabilities of the corporation, distribute all of the remaining assets and property of the corporation in accordance with applicable State law.
