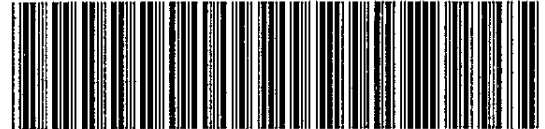



We, the undersigned, acting as Incorporator(s) designing to form a nonprofit corporation under the Law of Florida, Chapter 617, F.S., adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation is: MOUNT ZION HOLY TABERNACLE, INC., and its principal office is located at: 2319 PHILLMORE STREET, HOLLYWOOD, FL 33020.

ARTICLE II

This corporation shall have perpetual existence unless dissolved pursuant to law. Its existence shall commence upon filing with the Secretary of States.

ARTICLE III

The purpose for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempted from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, trustees, directors, officers or other private persons except that the corporation shall be empowered to pay reasonable compensation for service rendered and make payments and distributions in furtherance of section 501(c)(3) purpose. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

This corporation shall have the right to promote spiritual and intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, person and mixed. To operate a school of ministry, A christian school or accredited college, Int'l Ministries, crusades, world mission, concerts, banquets, school of music, radio ministry, a production studio, jail ministry and counseling.

ARTICLE IV

The address of the registered office of this corporation is: 2319 PHILLMORE STREET, HOLLYWOOD, FL 33020, and the registered agent is EDWIN P. HAY.

ARTICLE V

In the event of dissolution residual assets of the corporation will be turned over to one or more organizations which themselves are exempted as organizations described in section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government or exclusive public purpose.

ARTICLE VI

The number of Directors constituting the Board of Directors of this corporation are 4, and the members of the Board shall be elected and hold office in accordance with the Bylaws. Members of the corporation may provide such Bylaws for the conduct of its business and carrying out its purpose as they deem from time to time.
