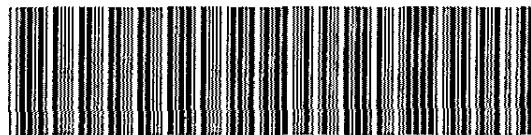

ARTICLE I: NAME

The name of the corporation shall be:

BREVARD ASSOCIATION OF VOLUNTEER MANAGEMENT, INC.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE

The purpose of the corporation is to provide leadership and training for volunteer organizations through the advancement of sound management practices, technical assistance and resource development. Further, to advocate, develop and operate volunteer outreach programs for the benefit of the citizens and communities of Brevard County.

ARTICLE IV: MANNER OF ELECTION

The corporation shall conduct an annual meeting, the date to be set in the by-laws, at which time a President, Vice-President, Secretary and Treasurer shall be elected by a majority of the membership in attendance, or casting its/her/his vote by proxy, as set forth in the by-laws, each to serve for a period of one year or until their successor has been elected. At the initial annual meeting of the corporation a minimum of 5 directors shall be elected, two to serve for a period of one year and 3 to serve for a period of two years, by a majority of the membership in attendance, or casting its/her/his vote by proxy, as set forth in the by-laws. At subsequent annual meetings, directors shall be elected each year, by a majority of the membership in attendance.
