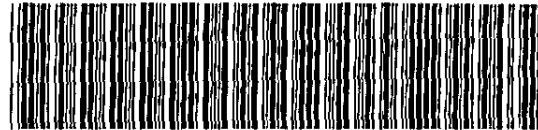


Ms. Hampton;
