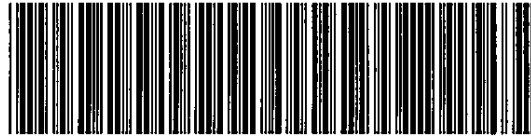

IN WITNESS WHEREOF, the undersigned has executed these Articles of Dissolution on April 24 2007, in Fort Myers, Lee County, Florida.



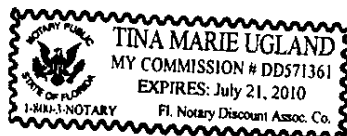


