Membership

Membership helps the staff to identify the people in whom we can trust to lead and care for others. It also identifies those that accept ownership of our "foyer-to-kitchen" strategy. Membership here is not just having a name on a list. Being a member indicates a willingness to partner and lead with us in our mission to lead people into a growing relationship with Jesus Christ. Because Authentic Community and Strategic Service are core values, we want our members to partner with us in achieving these. Requirements for Membership

Our membership is open for any individual that meets all of the following criteria:

- 1. Having a personal relationship with Jesus Christ.
- 2. Having been baptized SINCE accepting Christ.
- 3. Be willing to support this ministry with time, talents, and treasure, and be willing to be held accountable to the church in matters concerning relationship to God and to others.

If an individual meets the criteria for membership and wishes to so join Fellowship Church then he or she must attend a Q&A time. At this meeting he or she will be given an application for membership. It is our desire that every prospective member be fully on board or to reconsider their future membership at FC. This application can then be turned in to the church office, a ministry council member, any staff member. Final approval of the application will come from the Staff Leadership Team. The new member will be notified accordingly.

Removal of Membership

It is our desire to never remove someone from the membership of Fellowship Church. But, desire and willingness are two separate things. Therefore, membership may be removed under any of the following criteria:

- 1. Failure to attend at least one worship service during a three month period of time.
- 2. Failure to financially support Fellowship Church.
- 3. Causing division among Fellowship Church's members.
- 4. Publicly committing overt sin that may or does cause the reputation of Fellowship Church to be damaged in the community.

Restoration of Membership

Any membership that has been removed can be restored by the same process that it was initially given. However, if membership is removed due to either causing division among the congregation or publicly committing overt sin that damaged the church's reputation in the community then the one requesting to be restored must publicly repent before the congregation.
