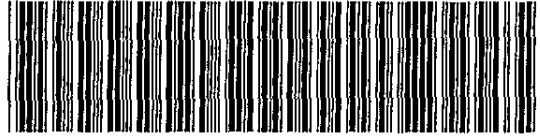

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt(s) the following articles of Incorporation:

### **Article I: Name**

### **Article III: Purpose(s)**
