ARTICLES OF INCORPORATION

OF

M. R.R. FOUNDATION, INC.

We, the undersigned, acting as incorporator, hereby form, pursuant to Chapter 617, Florida Statutes, under the laws of the State of Florida as a Corporation Not for Profit, and adopt the following Articles of Incorporation.

ARTICLE 1 - CORPORATE NAME

The name of this corporation shall be: M. R. R. FOUNDATION, INC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

ARTICLE III - NATURE OF BUSINESS AND POWERS

The principal nature and purposes for which this corporation is organized are listed in the Corporate Mission Statement and include but are not limited to:

a) To foster support against totalitarism and communism and help establish moral, practical, humanitarian, democratic values to liberate the oppressed people of Cuba and form one nation under God indivisible with liberty and justice for all; with respect for human rights, justice and the environment, where all peoples can live fruitful lives, free of economic slavery, in freedom, without political oppression;

- Ours is not a revolution but a true democratic crusade to establish freedom in Cuba, not only today but forever, to foster support to the civil society in Cuba, providing elementary and basic necessities to bring about changes towards a democracy through peace-full means; Stimulating visits to the human rights groups in Cuba by member of the human rights groups and international NGO's (Non-Governmental Organizations), journalist, academicians, artists, and representatives of democratic governments, in order to build the necessary relation between the Cuban civil society and their counterparts in the world; The shipment to human rights groups and activist in Cuba of the tools of democracy (fax machines, typewriters, computers, paper, pens, pencils and informative materials on democracy and free world economics and enterprises; Humanitarian and medical assistance to groups and dissidents inside Cuba, primarily to the political prisoners and their families; to use the Internet and any other possible media and means to communicate and denounce to the free world the violations of human rights in Cuba and inform as to the actual true conditions inside of Cuba.

- j) The corporation shall be empowered to develop it own intelligence unit and publish newspapers, pamphlets, books and magazines; acquire, rent, lease, let, hold, own, buy, convey, mortgage, bond, sell, or assign property; real, personal or mixed; as the purposes of the corporation whether expressed or implied shall require, associate itself with other persons, corporate or natural, for the purpose of becoming a member of an in otherwise associating itself with other corporations or associations of a similar or like nature; collect dues, fees, tents, fines, subscriptions, donations and other revenues to the advantage of the corporation and to do and perform all such other acts and things, including those generally allowed by the laws of the United States and the State of Florida relative to corporations not for profit, as now existing, or
