

ARTICLE III PURPOSE

TO ESTABLISH A MUSICAL ARTISTIC SOCIETY OPEN TO THE GENERAL PUBLIC TO FOSTER AN APPRECIATION OF THE PERFORMING ARTS & MUSIC THROUGH LECTURES, SEMINARS, STUDY GROUPS PUBLIC CLASSROOM PERFORMANCES, EXHIBITS AND ANY AND ALL APPROPRIATE MEANS .

THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR ONE OR MORE OF THE PURPOSES AS SPECIFIED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE INCLUDING FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. SPECIFIC OBJECTIONS AND PURPOSE OF THIS CORPORATION SHALL BE TO PROVIDE INSTRUCTION IN MUSIC, DANCE, & ART FORMS SUCH AS JAZZ HIP HOP BALLET TAP & MODERN DANCE. TO PROVIDE INSTRUCTION IN BODY MOVEMENT & RELAXATION ART FORMS SUCH AS CHA CHA, YOGA & REGGAE RHYTHMS. TO GIVE PUBLIC PERFORMANCES IN DANCE MUSIC ART FORMS AND CREATIVE DRAMATICS. TO SPONSOR SPECIAL EVENTS INVOLVING THE PUBLIC, PERFORMANCES OF ANY AND ALL OF THE ABOVE ART FORMS AS WELL AS OTHER PERFORMING ARTS BY THE CORPORATION'S PERFORMING TROUPE AS WELL AS BY OTHER COMMUNITY PERFORMING ART GROUPS AND TO DIRECTLY ENGAGE IN AND PROVIDE FACILITIES FOR OTHERS TO ENGAGE IN THE PROMOTIONS OF THE ARTS GENERALLY. TO SPONSOR OTHER INFORMATIONAL EVENTS OPEN TO THE PUBLIC WHICH FOCUS ON PERFORMING ARTS. TO EDUCATE THE PUBLIC CONCERNING OUR COMMUNITY CONTRIBUTIONS TO ARTS TO HELP MAKE MUSIC & ART AS INVITING AND ACCESSIBLE TO AS BROAD AN AUDIENCE AS POSSIBLE. TO ENGAGE IN OTHER ACTIVITIES RELATED TO EDUCATING TO THE PUBLIC ABOUT MUSIC AND ARTS IN OUR COMMUNITY.

ARTICLE IV MANNER OF ELECTION

OFFICERS SHALL BE ELECTED BY THE BOARD OF DIRECTORS AT ANY TIME AND EACH OFFICER SHALL HOLD OFFICE UNTIL HE OR SHE RESIGNS OR IS REMOVED OR IS OTHERWISE DISQUALIFIED TO SERVE OR UNTIL HIS OR HER SUCCESSOR SHALL BE ELECTED AND QUALIFIED WHICHEVER OCCURS FIRST. EACH MEMBER IS ENTITLED TO ONE VOTE ON EACH MATTER SUBMITTED TO A VOTE BY THE MEMBERS. VOTING AT DULY HELD MEETINGS SHALL BE BY VOICED VOTE. ELECTION OF DIRECTORS HOWEVER, SHALL BE BY WRITTEN BALLOT.
