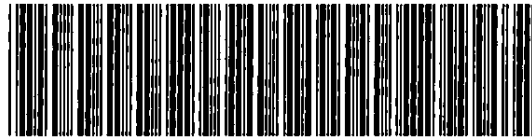

Reviving Souls Ministries Bylaws Amendments

Article IV. Self governing Church

- F. Members who are in good standing according to our bylaws may vote on issues presented by the Board of Trustees.
- G. The trustees may call a special meeting; notification will be given to members two weeks prior in writing.
- H. Congregational meetings shall be held twice a year to inform the members Of the Reviving Souls Ministries Church agenda.
- I. Voting. At least ten percent of all active members are entitled to vote on transactions approved by the Trustee Board for congregational approval.
- J Each member must be at 16 years or older and entitled to cast one vote. Members may vote in person, but not by proxy.

Article VII. Pastor and Church Administration

- A. The Senior Pastor shall preach the gospel, administer the ordinances, watch over the membership, have oversight over the spiritual welfare of the congregation and over see the scheduled public worship services.
- B.1 The Pastor shall have a Ministerial cabinet of licensed Associate Ministers Elected by the Pastor according to the Standards given by the Holy Bible in the book of Titus, I Timothy, Acts, and I Corinthians. They are chosen to help the Pastor carry out the Mission and the Purpose of Reviving Souls Ministries.
- 2. All candidates for licensing or ordination must be an active member of Reviving Souls for at least 6 months or more before they are considered as a candidate for an office as a Minister. The Candidates license will be valid for a one- probationary period. During that year the candidate must be involved in Ministry within and outside the Church, in visitation, and preaching as well as other duties deemed appropriate by the Pastor. To be approved for ordination, the candidate shall take and pass a written or oral exam and face other ordained clergy. Upon this being approved, the candidate may be presented to the Church congregation for ordination.
- B. The Associate Ministers shall assist in the teaching of the Word of God. They shall help the Pastor establish the Vision of the Ministry through outreach programs, revivals, visitations, food and clothing distribution. They shall over see the process of new member orientation.

Section 2. Tithe and Offerings

- A. Reviving Souls Ministries shall be supported by the tithe and offerings Given by members and friends. The tithe shall be distributed as needed through out the ministry.**
- B. The Trustee Board must approve all distributions payment for services, or Business related to the operation of the Church. The Pastor may establish reasonable procedures for authorizing emergency expenditures and cash expenditures as necessary for the efficient operation of the Church.**
- C. The Trustee Board must approve a fixed percentage to compensate the the Pastor as an employee. All travel and on behalf of the Ministry by the Pastor will be supported by an approved percentage from the outreach budget.**
- D. In the event that the Senior Pastor and Chief Executive Trustee, Kamia White expires, if there is no recommendation from the Trustee Board and approved replacement, Reviving Souls Ministries will be Dissolved.**
- E. Dissolution Clause**
In the event of the dissolution of Reviving Souls Ministries, any assets of this organization remaining thereafter shall be conveyed by the Trustee Board of the organization at the time of dissolution to such other organization or organizations as, in the opinion of the Trustee Board, is best fitted to carry on the objectives of this organization or objectives closely allied thereto, provided, however that the successor organization shall, at the time of designation, be exempt under 501(C) (3) of the Internal Revenue Code of 1954 as amended or under such successor provision of the code as then may be in effect.
- F. Nonprofit Status**
No part of the net assets of Reviving Souls Ministries shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for service rendered and make payments and distribution in furtherance of the purpose set forth in Articles IV and VII hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in

(including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the organization shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax as an organization described in section 501 (C) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code.)

Article VIII. Amendments

- G. These Bylaws may be amended at any special meeting of the Board of Trustees called for that purpose. The members will be notified of the meeting Concerning the proposed Amendments being amended. The Trustee Board must approve all proposed amendments and they shall become effective immediately.
