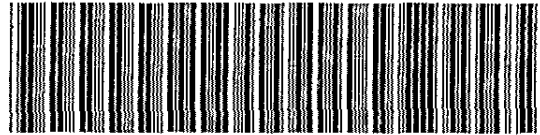



## **ARTICLES OF INCORPORATION**

CLERK OF STATE

- ARTICLE I:** The Name of the corporation shall be called "**Friends of the Father, Inc.**"
- ARTICLE II:** The principal place of business and mailing address of the corporation is:
- 5357-81<sup>st</sup> Street North #9, St. Petersburg, FL 33709**
- ARTICLE III:** The specific purposes for which the corporation is organized are:
1. To provide consulting for low income families in order to acquire housing utilizing government programs designed to assist them,
  2. To organize acquisition of property and preparation of land
  3. To organize building of homes
  4. To consult in obtaining financing and securing down payments
  5. To assist in acquiring energy efficiency and protection from elements
  6. To provide employment for people at or below the poverty level
  7. To provide job training and education for people at or below the poverty level
  8. To provide housing for disadvantaged, disabled and elderly utilizing government programs
  9. To conduct any and all lawful business connected to assisting in the foregoing purposes.
- ARTICLE IV:** The Directors will be appointed initially by the Chairman of the Board and elected annually by majority vote of the Directors.
