**ARTICLES OF INCORPORATION
OF
FIRST UNITED METHODIST CHURCH OF MILTON, INC.**

ARTICLE I - NAME

The name of this corporation is FIRST UNITED METHODIST CHURCH OF MILTON, INC., a non-profit corporation with its principal place of business located at 6819 Berryhill Street, Milton, FL 32570.

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose to preach, teach and study the gospel of Christ; to advance its membership in faith, hope and charity and to become a part of the United Methodist Church and of transacting any and all lawful business not inconsistent with the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This corporation is a corporation not-for-profit and shall not issue stock.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 5520 Shamrock Street, Milton, FL 32570, and the initial registered agent of this corporation at that address is G. Medders.

ARTICLE VI - INITIAL TRUSTEES





6. The By-Laws of the Corporation shall include the discipline of the United Methodist Church as enacted from time to time by the General Conference.


