ARTICLE I NAME

The name of the corporation is COCOA BEACH DAYBREAK ROTARY CLUB FOUNDATION, INC.

The purpose for which the corporation is organized is: This is a nonprofit corporation primarily organized solely for general educational and general charitable purposes pursuant to the Florida Corporation not for profit law set forth in Section 617 of the Florida Statutes (2003). The general and specific purposes for which this corporation is formed

- A. For the advancement of the principles of Rotary International and any other related or corresponding charitable purposes by the distribution of its funds for such proposes.
- B. To operate exclusively in any other manner for such charitable and educational purposes as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provisions of any subsequent Federal tax laws, covering the distributions to organizations qualified as tax exempt organizations under the Internal Revenue Code, as amended, including private foundations, private operating foundations or public charity.
- C. In the event of dissolution of this federation, all assets will be distributed to a 501(c)(3) organization with like purposes.

The following are some of the specific projects that have been undertaken by the Cocoa Beach Daybreak:

A. RotaKids

Cocoa Beach Daybreak supports a charter for RotaKids Clubs at Capeview Elementary school. This program helps children build self-esteem and teaches them the value of service to others. This program also allows our club to stay aware of contemporary challenges facing our children. We have participated in this program for XX years and normally there are XX children participating each year.

- B. Rotary Youth Leadership Awards (RYLA) Cocoa Beach yearly supports the Rotary Youth Leadership Awards (RYLA) program that is worldwide for young people ages 14-30 chosen for their leadership potential. We pay for each to attend an all-expenses-paid seminar, camp, or workshop to discuss leadership skills and to learn those skills through practice. The purpose is to demonstrate Rotary's respect and concern for youth; to provide an effective training experience for selected youth and potential leaders; to encourage leadership of youth by youth; and to recognize publicly young people who are rendering service to their communities. RYLA participants often go on to become Youth Exchange students or Ambassadorial Scholars.
- C. Heifer International
 Cocoa Beach Daybreak supports a charter for RotaKids Clubs at Capeview
 Elementary school. This program helps children build self-esteem and
 teaches them the value of service to others. This program also allows
 our club to stay aware of contemporary challenges facing our children.

- D. Polio Plus
 Rotary International launched the PolioPlus program to protect children worldwide from the cruel and fatal consequences of polio. In 1988, the World Health Assembly challenged the world to eradicate polio. Since that time, Rotary's efforts and those of partner agencies, including the World Health Organization, the United Nations Children's Fund, the United States Centers for Disease Control and Prevention, and governments around the world, have achieved a 99 percent reduction in the number of polio cases worldwide. Cocoa Beach Daybreak has supported this cause for the last two years.
