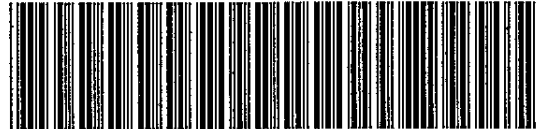

ARTICLES OF INCORPORATION

of

EAST WOODLAND ROAD HOME AND LAND OWNERS, INC.  
a not for profit corporation  
incorporated pursuant to  
Florida Statutes, Chapter 617

ARTICLE ONE - NAME

The name of the corporation shall be: East Woodland Road Home and Land Owners, Inc.

ARTICLE TWO - PRINCIPAL OFFICE

The principal office of the corporation will be: 1134 Harrison Avenue, Panama City, Florida 32401.

ARTICLE THREE - PURPOSE

The purpose for which the corporation is organized is: To maintain the roadways and other areas of common interest; to do other acts so as to provide for the general welfare of the owners of residences and lots within the East Woodland Road development area; to collect money from the owners to pay for same, and to maintain bank accounts so as to disburse money for same.

ARTICLE FOUR - SHAREHOLDERS

All owners of lots within East Woodland Road development shall be shareholders with one vote per dwelling unit and if there is no dwelling unit, then one vote per lot.

ARTICLE FIVE - MANNER OF ELECTION

The manner in which the directors are elected or appointed: By a majority vote of the shareholders that attend the meeting for said elections.

ARTICLE SIX - INITIAL MEETING

The initial meeting of the shareholders shall be 30 days from the effective date of this charter and an annual meeting to be held each year thereafter, with the date and place being selected at each annual meeting. Special meetings may be called by a majority of the Board of Directors.

ARTICLE SEVEN - INITIAL DIRECTORS/OFFICERS

Initially the corporation shall have five directors and the number may vary by vote of the shareholders but never be less than three. The initial directors shall be Jeff Parish, Val Cullen, Rachel Kinard, Chris Morris, and Christina Ottley. The initial officers shall be Jeff Parish - President, Chris Morris - Vice-President, Rachel Kinard - Secretary, and Val Cullen - Treasurer.

ARTICLE EIGHT - INITIAL REGISTERED AGENT AND STREET ADDRESS

The initial registered agent and street address of the registered agent are Val Cullen at 1134 Harrison Avenue, Panama City, FL 32401.

ARTICLE NINE - INCORPORATOR


