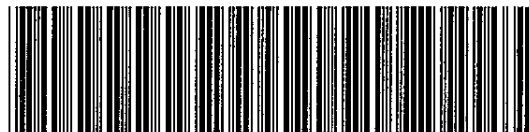

Articles of Incorporation Volusia/Flagler PHCC, Incorporated

Article I – Name

The name of the corporation shall be the "**Volusia/Flagler PHCC, Incorporated.**" Hereinafter, any reference to the Association in these Bylaws refers in particular to the Volusia/Flagler PHCC, Incorporated.

Article II - Purpose

This is a non-profit corporation organized pursuant to the Florida Corporation Not For Profit Law set forth in Part I, Chapter 617, Florida Statutes and is organized:

- (1) To gather, receive and disseminate information among its members for the advancement of plumbing-heating-cooling and the public health;
- (2) To foster, promote and encourage the improvement of plumbing-heating-cooling materials and work.
- (3) To encourage the enactment and enforcement of plumbing-heating-cooling legislation;
- (4) To foster and promote the education of the apprentice and journeyman;
- (5) To foster and promote goodwill between plumbing-heating-cooling contractors and other branches of the construction, and to encourage the observance of the highest ethical standards in all matters pertaining to the plumbing-heating-cooling business;
- (6) To consider and deal with the problems of management in the plumbing-heating-cooling industry: to secure cooperative action in advancing the common purposes of its members; to foster equity in business usages, and to promote activities which will enable the industry to conduct itself with the greatest economy and efficiency.

Article III – Membership

Membership in this Association shall be limited to those corporations, firms, proprietorships and such other organizations and individuals who are engaged in the plumbing and/or heating and/or cooling and/or

mechanical contracting industry, regularly carrying on such business in the State of Florida, and with an established place of business, shall be eligible for membership in this Association.

Article IV – Term

The term for which this Organization shall exist shall be perpetual.

Article V – Officers and Managers

The officers of this corporation are to be a President, a President-Elect, a Vice-President, a Secretary, a Treasurer and a State Director who are to be elected via a secret ballot and who take office at the first regular meeting in January and shall serve for one year. The officers of this corporation shall manage its affairs. The officers of this corporation shall be its managers and shall be 6 in number. Article VI – Location of Principal Office and Designation of Resident Agent


