ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, do hereby make and adopt the following Articles of Incorporation:

ARTICLE I - Name. The name of the Corporation shall be It's A Love Thang Ministry, Inc.

ARTICLE II - Address. The principal place of business and mailing address of this corporation shall be: 11432 Lakeview Drive, Coral Springs, FL 33071.

ARTICLE III - Not For Profit. The corporation is a nonprofit corporation under the laws of the State of Florida. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is distributable to or for the benefit of its Members, Trustees or Officers, except to the extent permissible by law.

ARTICLE IV - Duration. The duration (term) of the Corporation is perpetual.

ARTICLE V - Purpose. The Corporation is organized, and shall be operated exclusively for the following purposes:

- A. To conduct non-denominational church services.
- B. To teach its members to Worship God in Spirit and in truth.
- C. To evangelize and teach about the saving knowledge of Jesus Christ.
- D. To assist in charitable work of any nature deemed beneficial to the church and the community.
- E. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations, including

without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property and the income, principal and proceeds of such property, for any of the purposes set forth herein.

- F. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE VI - Limitation.

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its Members, Trustees or Officers, but the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V. (Purposes)

ARTICLE VII - Initial Registered Office and Agent.

The street address of the initial Registered Office of the Corporation is 1000 W. McNab Road, Suite 161, Pompano Beach, FL 33069, and the name of the initial Registered Agent at that address is Samuel A. Price.

ARTICLE VIII - Officers.

The Officers of the Corporation shall consist of a President, Secretary, Treasurer, and such other Officers and Assistant Officers as may be provided in the Bylaws. Each Officer shall be elected by the Board of Trustees (and may be removed by the Board of Trustees) at such time and in such manner as may be prescribed by the Bylaws. 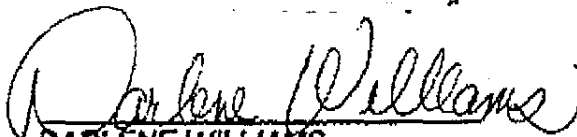

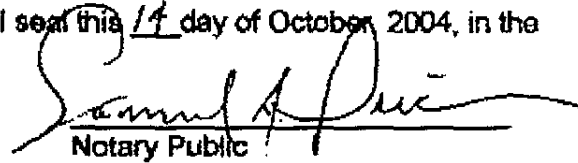

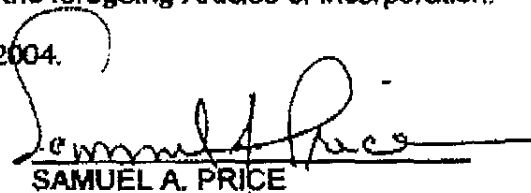
