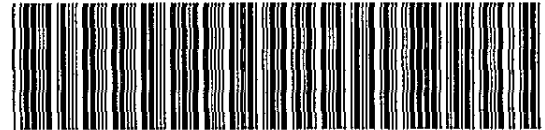

In compliance with the requirements of Chapter 617 F.S. (Not for Profit), the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing these articles of incorporation for the purpose of organizing a Not for Profit organization.

ARTICLE I. NAME OF CORPORATION

The name of the Corporation ("Corporation") is *Shepherd's Gathering, Inc.*

ARTICLE II. PRINCIPLE OFFICE

The street address of the principle office of the Corporation is 6432 Huntington Lakes Circle #204, Naples, FL 34119.

ARTICLE III. PURPOSE

This Corporation is being formed exclusively for charitable and religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future Federal tax code. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code.

ARTICLE IV. EARNINGS OF CORPORATION

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE V. ELECTION OF BOARD OF DIRECTORS

The initial board of directors shall consist of three (3) members. This number may be increased or decreased from time to time in accordance with the Corporation's by-laws, but shall never be less than one. The board of directors will be selected as stated in the Corporation's by-laws. The names and addresses of the persons who will serve on the initial board of directors are:

ARTICLE VI. INITIAL REGISTERED AGENT

ARTICLE VII. DISSOLUTION

Upon dissolution of the Corporation, all remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future Federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes as said Court shall determine, which are organized and operated exclusively for such purposes.

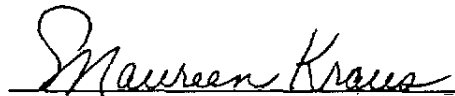
