ARTICLE III —PURPOSE

The purpose for which the corporation is organized is:

Conduct prayer fellowship and Church Ministry along with promote Gospel of Jesus Christ to the unreached over United States and other nations. This may include personal and literature evangelism, spiritual and financial support to the gospel workers and charity work. This corporation may also support Church planting in appropriate areas. ARTICLE IV—MANNER OF ELECTION

The manner in which directors are elected or appointed:

- (3) The President of the corporation shall be a Holy Spirit anointed minister of God, who has a divine call from God to reach out the unreached for the kingdom of God through the gospel of Jesus Christ
- (4) **Our Faith and Belief: *We believe:-***

.....in sanctification.....

Sanctification in an act of keeping oneself separated from that which is evil and dedicating unto God (Romans 12:1-2., 1 Thessalonians 5:23; Hebrews 13:12).

The Bible teaches us a life of holiness, and “without holiness no one shall see God”. (Hebrews 12:14). We are able to obey this commandment only by self dedication and by submitting to the power Holy spirit. “Be ye holy, for I am holy” (1 Peter 1:15,16).




