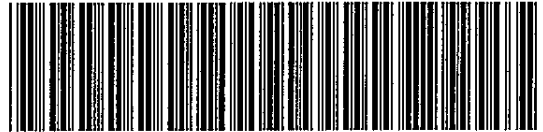

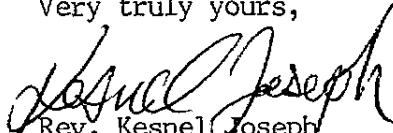

ARTICLES OF INCORPORATION
FOR
CHRISTIAN REFUGEE CENTER & OUTREACH MINISTRIES, INC.

The undersigned, acting as incorporator(s) pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is: CHRISTIAN REFUGEE CENTER & OUTREACH MINISTRIES, INC. and its principal address of the corporation is: 2150 NORTHEAST 1ST AVENUE, POMPAÑO BEACH, FL 33060.

ARTICLE II

The period of duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing with the Secretary of State.

ARTICLE III

The purpose for which the corporation is organized is formed solely for religious purposes, for charitable, scientific, literary, and educational, with the meaning of Section 501(c)(3) of the Internal Revenue Code. No substantial part of of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities premitted to be carried on by an organization Exempt from the Federal Income Tax under section 501(c)(3) of the present Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law. No part of the net earnings of the corporation shall inure to the benefits of, or be distributable to its members, trustees, director, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and make payments and distributions in furtherance of Section 501(c)(3) purpose.

This corporation shall have the right to promote intellectual welfare of the people of the State of Florida; the buying, selling, conveying, accepting and being invested with all manner of estate, real, personal and mixed. To do Children and youth tutoring, to have a homeless ministry, HIV/AIDS Ministry, Food Pantry, Day Care Center, Clothing Ministry, Alcohol/Drugs Ministry, After School Care, Summer Camp, Seniors Ministry, Refugee Resettlement, Parentical Classes, Praise & Dance Ministry, Praise & Worship Ministry, Chaplain Ministry, Multi-Housing Ministry, Debt Consolidation Ministry, Jail Ministry and Counseling Ministry.

ARTICLE IV

The qualifications for members and the manner of their admission is to be provided for in the Bylaws.

ARTICLE V

The street address and city of the initial registered office of the corporation is: 2150 NORTHEAST 1ST AVENUE, POMPANO BEACH, FL 33060, and the name of the registered agent at such address is Rev. Kesnel Joseph.

ARTICLE VI

The number of Directors constituting the Board of Directors of this corporation are 6, and the members of the Board of Director shall be elected and hold office in accordance with the Bylaws. Members of this corporation may provide such Bylaws for the conduct of its business and the carrying out its purpose as they deem from time to time.
