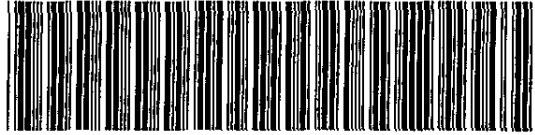

**ARTICLES OF INCORPORATION**

In Compliance with Chapter 617, F.S., (Not for Profit)

**YOUTH EDUCATION & SPORTS PROGRAMS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation shall be:

**YOUTH EDUCATION & SPORTS PROGRAMS, INC.**

**ARTICLE II**

**PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III**

**PURPOSE**

This corporation is organized for the purpose of implementing, servicing and supporting educational, social and recreational programs and activities to youth and families in the community in an effort to encourage and increase community cohesiveness and productivity, and to decrease prevalent problems such as juvenile crime, teen pregnancy, drug activity and school drop out.

Notwithstanding the above, Youth Education & Sports Programs, Inc. shall engage in the general activities of:

- A. Investing the funds of this corporation in real estate, stocks, bonds, entertainment, or any other type of investments, and to own real and personal property necessary for the benefit of the programs.
- B. To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or objectives of this corporation enumerated in these Articles of

Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of this corporation; and in general, either alone or in association with other corporations, firms, individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objectives of this corporation.

- C. It is intended that this corporation may conduct and transact any business lawfully authorized and not prohibited by the laws of the United States and the State of Florida.

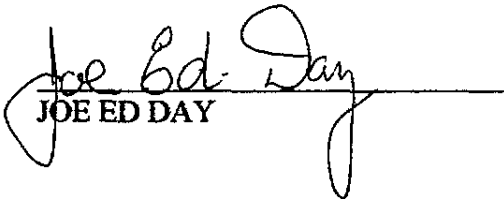

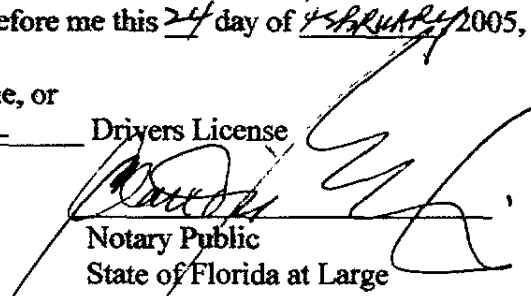

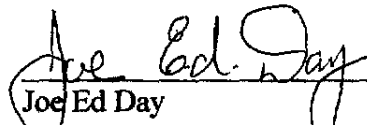
