A Nonprofit Corporation

Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned  
incorporator hereby adopt the following Articles of Incorporation:

**Article 1**

The name of this corporation is:  
OkimaT Organization, Incorporated

**Article 2**

The initial address of the principal office of this corporation is:  
37 Constitution Ave DeFuniak Springs, Florida 32433

**Article 3**

The purposes for which this corporation is organized is:

To prevent drug/alcohol usage and deter interaction with the criminal justice system by inspiring developing youths ages 12 through 18 of DeFuniak Springs, Florida to focus on their education and future while encouraging them to take an active role in their community. Achieving our goals is completed through a series of workshops training, seminars, mentoring programs and contact with the youths regularly.

**Article 4**

The initial Board of Directors shall consist of three members. The number of directors may increase from time to time as provided by the Bylaws, but shall never be less than three. Directors shall be elected in accordance with the Bylaws. The directors shall elect officers from the body of directors or qualified candidates in accordance with the Bylaws. The Board of Directors shall meet at least twice a year (one time may be the annual conference) to discharge their responsibilities as given in these bylaws. Voting for the election of the directors shall be by written ballot. Each director shall cast one vote per candidate. The candidates receiving the highest number of votes up to the number of directors to be elected shall be elected to serve on the board.

Vacancies on the Board of Directors shall exist (1) on the death resignation, or removal of any director and (2) whenever the number of authorized directors is increased. A person elected to fill a vacancy on the board shall hold office until the next election of the Board of Directors or until his or her death, resignation, or removal from office. The Board of Directors shall elect officers, at anytime. Officers elected shall serve for a term

of two years or until he/ she resigns or is removed or is otherwise disqualified to serve, or until his or her successor shall be elected and qualified, whichever occurs first.

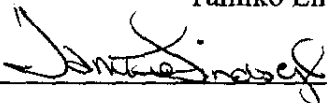

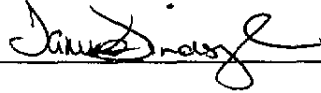
