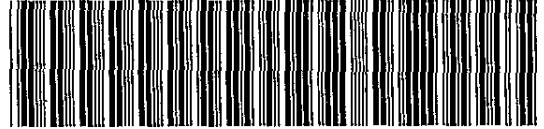

We, the undersigned, with other persons being desirous of forming a not-for-profit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be:

Cinderic Documentaries, Inc

The address of the principal office of this corporation shall be

and the mailing address of the corporation shall be the same.

ARTICLE II

Said corporation is organized exclusively for charitable, educational, and literary purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Code. Cinderic Documentaries, Inc. will promote projects of social, cultural, and industrial diversity and strive to explore traditional ideas and beliefs that are important to the community, neighborhood, organization, and family. The goal of Cinderic Documentaries, Inc. is to enrich and preserve the community and human spirit through special photographic documentary projects of lectures, presentations, exhibitions, and publications to the general public.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in sections 501 (c)(3) and 170(c)(2) of the Internal Revenue Code of 1986

or the corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.

ARTICLE III

The manner in which the directors are to be elected or appointed is as stated in the bylaws.

ARTICLE IV
