**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
CORINTHEAN OF WINTER PARK, INC.**

Pursuant to the requirements of Sections 617.1002 and 617.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of CORINTHEAN OF WINTER PARK, INC. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on March 9, 2005 under Document No. N05000002384.

1. The Incorporator of the Corporation hereby makes the following change to the Articles of Incorporation:

- a. Article I of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

The name of the Corporation is:


THE CORINTHEAN OF WINTER PARK CONDOMINIUM ASSOCIATION, INC.
