## ARTICLES OF INCORPORATION

OF

The Solid Rock Korean Church, Inc.

A Nonprofit Corporation

The undersigned, acting as incorporator(s) of The Solid Rock Korean Church, Inc., under Chapter 617 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

### ARTICLE I

The name of the corporation shall be The Solid Rock Korean Church, Inc. and shall be situate at 3600 West S.R. 426, Oviedo, FL 32765.

### ARTICLE II

The specific purpose(s) for which the corporation is organized is (are) to practice Christianity and this corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section (c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code.

### ARTICLE III

The initial registered agent and the address of the initial registered office at such address is Hyun H. Park at 3600 W. S.R. 426, Oviedo, FL 32765.

### ARTICLES IV

The corporation shall have members and the qualification will be as set forth in the bylaws.


or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to as a state or local government, for a public purpose. Any such asset not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.

### ARTICLES XI

**Other provisions:** Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

No part of the net earning of this corporation shall inure to the benefits of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.
