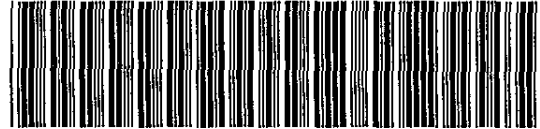

OF

ARTICLE I-NAME

The name of the non-profit organization shall be:

ARTICLE II-PRINCIPAL OFFICE

ARTICLES III-PURPOSE

This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-Profit Public Benefit Corporation law, for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but not be limited to: Housing, Outreach Advocacy for the Homeless and Disadvantaged, Health care, Employment, Literacy, Counseling, Seminars, Temporary Shelter, Teenage Pregnancy, Job Training, Library, Job Placement and Acquisition, Substance Abuse Awareness and Prevention, Tutoring AIDS Awareness, Elderly Care and other programs to aid those in need.

- (a) This organization is further organized and operated to increase the positive growth and development of individuals with a history of dysfunctional social problems and substance abuse. This corporation shall to provide instruction and training in social and occupational skills that will enable individuals to improve their capabilities on the subjects useful the individual and beneficial the community. The organization will also endeavor to further educate individual in the area of a "drug-free" lifestyle in order to reduce the risk of destructive behavior.
- (b) Not -withstanding any other provisions of these articles the corporation shall not carry on any other activity not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

RTICLE X-CORPORATION DISOLUTION

Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
