Clause a.

Furthermore, the organization will not participate in or intervene in any political activity whatsoever. Therefore, it will not pursue political propaganda or literature or otherwise influence legislation on behalf of any candidate or public office.

Clause c.

Upon the dissolution of the organization, assets shall be distributed to the local government in this case to the Town of Huaylas. From that point on, it will continue operating and administering the given services set forth. It will be stated that this contribution of good will is from the American, Peruvian American people, members and donors of the organization based on the State of Florida of the United States of America as a way and means to help or gift to the town and the surrounding communities to continue operating and providing new opportunities to our people of this undeveloped country.
