OF

ARTICLE I

Name

The name of the corporation is: Unlimited Success Community Services, Inc.
(hereinafter referred to as "Unlimited Success").

ARTICLE II

Purpose

The purposes for which the corporation is organized include making resources available for those who desire better lives for their families and community by eliminating the negative family cycles. Services will be provided primarily to citizens in the Gadsden County and Big Bend area. The youth services will include Juvenile Justice, After School and Summer Programs. Adult programs will include Parenting and College/Job Readiness Classes. Notwithstanding any other provision of these articles, this corporation will not conduct any activity not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Code of 1954 or the corresponding provision of any future United States Internal Revenue law.


