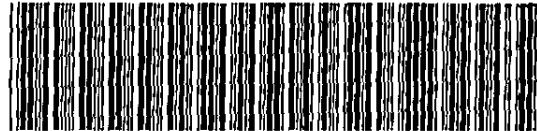

OF

The undersigned, acting as incorporator of this corporation pursuant to Chapter 617 of the Florida Statutes hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I
NAME

The name of this corporation shall be National Inspectors Risk Association, Inc.

ARTICLE II
PRINCIPAL OFFICE

The street address of the initial principal office and if different, the mailing address of the corporation are:

ARTICLE III
GENERAL PURPOSE

The general purpose for which this corporation is organized shall be:

A. This corporation is a home inspection industry advocate providing educational information and quality risk management programs to the home inspection industry. It assists lobbying efforts through lawmakers and organizations to add integrity and promote the inspection industry.

ARTICLE IV
CAPITAL STOCK

A. This corporation shall be organized on a nonstock basis.

B. No part of net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE V
QUALIFICATIONS FOR MEMBERS
AND MANNER OF ADMISSION

The qualifications for members and manner of their admission shall be regulated by the By-Laws.

ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT

The initial street address of the registered office of this corporation in the State of Florida will be 234 N. Westmonte Drive, Suite 3000, Altamonte Springs, Florida 32714. The Board of Directors may from time to time move the registered office to any other address in Florida. The name of the initial registered agent of this corporation at that address is Stephen C. L. Chong. The Board of Directors may from time to time designate a new registered agent.

ARTICLE VII
INITIAL BOARD OF DIRECTORS

A. This corporation shall have three (3) Directors initially. Thereafter, the manner in which directors will be elected or appointed shall be stated in the By-Laws.

B. The number of Directors may be increased or diminished from time to time by By-Laws adopted by the shareholders, but shall never be less than three (3) Directors pursuant to Section 617.0803, Florida Statutes.

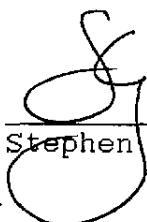
