# ARTICLES OF INCORPORATION

The undersigned incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

# ARTICLE I

The name of the corporation shall be JCOTA, Inc.

## ARTICLE II

The principal place of business and mailing address of this corporation shall be 1678 Victoria Pointe Circle, Weston, FL 33327.

# ARTICLE III

The purpose for which the corporation is organized is to operated exclusively for charitable, educational, scientific, and literary purposes, within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 (or corresponding provisions of any subsequent federal tax laws)(hereinafter call the "Code"); and within such limits to raise money which will then be used to purchase and renovate buildings for use as low income housing/homeless shelters, adoption centers, medical facilities which will accept indigent individuals, etc; and to engage in any other charitable purposes, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the Code.

## ARTICLE IV

The affairs of this corporation shall be managed by its Board of Directors. The number of directors (not less than three) and the manner of choosing directors shall be fixed in the By-laws.

### <u>ARTICLE V</u>

The name and Florida street address of the initial registered agent are: Dr. William Chandler Reynolds, 1678 Victoria Pointe Circle, Weston, FL 33327

## ARTICLE VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under the Code or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE VII

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes as shall at the time qualify as an exempt organization or organization under Section 501(c)(3) of the Code, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, s the Court shall determine, which are organized and operated exclusively for such purposes.
