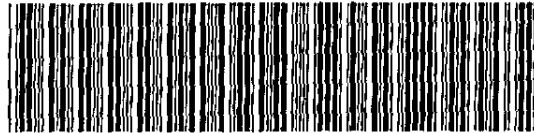

**ARTICLES OF INCORPORATION**  
In Compliance with Chapter 617, F.S.. (Not for Profit)

**ARTICLE I      NAME**

The name of the corporation shall be:  
NFS Charities, Inc.

**ARTICLE II      PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
1945 Sunset Point Road, Suite 1, Clearwater, FL 33765

**ARTICLE III      PURPOSE**

The purpose for which the corporation is organized is:

The organization is organized exclusively for charitable, religious, educational purposes under section 501(c)(3) of the Internal Revenue Code. The purpose of NFS Charities is to raise funds through contributions from companies and individuals, to help support new and growing churches, to offer scholarships to individuals entering the ministry fields, and to support local activities and events that spread the news of Jesus and His Resurrection.

**ARTICLE IV      MEMBERSHIP**

Membership is open to anyone who wants to become a voting member. A membership fee may be charged. Members receive no other benefits other than the right to submit projects to be funded to the Board, and voting rights.

**ARTICLE V      BOARD OF DIRECTORS**

The Board of Directors should not contain less than three members. The Board is not to exceed nine members. Four officers of the Board will be elected every year. Those offices are President, Vice President, Secretary, and Treasurer. The Board members are elected to two year terms with no more than ½ of the Board being replaced in any one year.

**ARTICLE VI      MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

All members will be given notice 120 days prior to election and may submit themselves or other members as candidates for the Board. The members then vote for their Board members.




